1. Who We Are

 - Process payments and issue invoices.
 - Comply with legal or regulatory requirements.
 - Improve our website and customer experience.
 - (If opted in) Send you updates, news, and promotional offers.

4. Legal Basis for Processing

We process personal data under the following legal grounds (in line with GDPR):

- **Contract:** to deliver the services you request.
 - **Consent:** when you opt in to receive marketing communications.
 - **Legal obligation:** to comply with financial and tax laws.
 - **Legitimate interests:** to improve our services and protect our business.

5. Sharing Your Information

We do not sell or rent personal data. We may share information with:

- Trusted service providers (e.g., payment processors, IT providers).
- Hunting and accommodation partners in Hungary (only essential booking details).
- Regulatory or legal authorities where required.

All third parties must respect your data and process it only as instructed.

6. Cookies and Tracking

Our website may use cookies to:

- Improve site performance and user experience.
- Analyse traffic and visitor behaviour.
- Enable certain features (e.g., booking forms).

You can manage cookies through your browser settings.

7. Data Storage and Security
